### **Major General Philippe Adam**



#### Space Commander, Air and Space Force, Paris

Major General Philippe Adam has comprehensive technical and operational experience. After attending the National War College in Washington, D.C. in 2010-2011, he joined the NATO International Military Staff in Brussels as Deputy Chief of the "Air and Ballistic Missile Defense" Branch. In 2013, he was appointed deputy director of the Euro-Atlantic branch at the French Delegation for Strategic Affairs, in charge of supporting the defense minister for bilateral and multilateral meetings. From 2015 to 2017, he was assigned to the Air Defense and Air Operations Command at Lyon Mont-Verdun Air Base 942, as commander of the National Air Operation Center. Promoted to Brigadier General in 2017, he then took command of the Air Operation Brigade, still at BA942. Then, in summer 2018, he was appointed deputy Joint Force Commander of the Barkhane Operation, in N'Djamena, Chad. In 2019, he took command of the French Air Warfare Center in Mont-de-Marsan. In 2020, he was appointed chief of the "Future Capabilities" division of the Joint Staff, in charge of planning the procurement of future equipment on behalf of the Joint Chief of Staff. He took command of the French Space Command on July 1st, 2022.

### Ylli Bajraktari



#### Chief Executive Officer, Special Competitive Studies Project

Mr. YIII Bajraktari is the Chief Executive Officer of the Special Competitive Studies Project (SCSP). Prior to joining SCSP, he served as the Executive Director of the National Security Commission on Artificial Intelligence, served as Chief of Staff to the National Security Advisor LTG H.R. McMaster, held a variety of leadership roles for former Deputy Secretary of Defense Robert Work, and served as Special Assistant to the Chairman of the Joint Chiefs of Staff, General Dempsey. Originally joining the Department of Defense in 2010, he served in the Office of the Undersecretary for Policy as a country director for Afghanistan, and later India. Mr. Bajraktari is the recipient of the Department of Defense Distinguished Civilian Service Medal – the highest award given to career DoD civilian employees.

### **Justin Bassi**



#### **Executive Director, Australian Strategic Policy Institute**

Justin Bassi is the Executive Director of the Australian Strategic Policy Institute. From June 2019 to March 2022 he was Chief of Staff to the Minister for Foreign Affairs and Minister for Women, Senator Hon. Marise Payne. Immediately prior to this, Justin was the Cyber Intelligence Mission Manager at the Office of National Intelligence, where he led the integration of cyber security and critical technologies across the National Intelligence Community. From September 2015 to August 2018, Justin was the National Security Adviser to Prime Minister Malcolm Turnbull. He led the team advising the PM and Cabinet Ministers on Australia's national security, defence and international relations. This included responsibility for all areas of security legislation, policy and operations, including counter terrorism, foreign interference, cyberspace, intelligence and border security. Justin was also previously the National Security Adviser to Attorney-General George Brandis, focusing on Australia's national security legislation, policy and activities, including counter terrorism and telecommunications security. Prior to that, Justin spent over 10 years in the Australian Public Service, including in the intelligence community for the Office of National Assessments and at the Department of the Prime Minister and Cabinet where he had responsibility for cyber security policy.

### **Steve Baxter**



#### Co-founder and Executive Chairman, TEN13

Tech start-up investor Steve Baxter is a proud Queenslander, born in the remote town of Cloncurry and raised in Emerald in the State's central highlands. In 1994, at the age of 23, Steve put his life savings of \$11,000 on the line to launch his first start-up, the pioneering internet service provider SE Net, from the spare room of his Adelaide home. Servicing more than 35,000 customers, SE Net was eventually acquired by Ozemail/UUNet under the stewardship of its founding Director and Former Prime Minister, Malcolm Turnbull, In 2001, Steve teamed with a schoolmate to launch his second start-up, PIPE Networks, a provider of wholesale telecoms infrastructure that was listed on the ASX in 2005. Eight years later they sold it to the TPG Group for \$373 million. Steve spent a year working with Google in California in 2008, leading a project to deliver high-speed telecommunications systems across North America. Steve is now the Co-founder and Executive Chairman of TEN13, Australia's leading tech startup investment platform, and Founder and Lead Investor with Beaten Zone Venture Partners which is dedicated to early stage investments in Australian sovereign legal defence technology.

### **Kelly Bayer Rosmarin**



#### Chief Executive Officer, Optus

Kelly Bayer Rosmarin is a corporate executive known for her exceptional combination of astute business acumen and creativity, who has emerged as a disrupter of traditional markets through her ability to leverage digital technology. Bayer Rosmarin commenced as CEO of Optus and Consumer Australia on 1 April 2020, after joining the company as Deputy CEO on 1 March 2019. In her tenure as CEO, she has driven a significant uplift in employee engagement and corporate culture. Bayer Rosmarin spearheaded a shift in Optus' strategic direction, with the company uniting in its strong purpose and customer-centric ambition to empower and enrich customers' experiences and connectivity. Optus' evolution from a telco to a technology company is demonstrated by the industry-leading launches of the 'Living Network', subscription aggregator platform 'SubHub', and smart devices and installation services delivered by Smart Spaces and the O-Team. Prior to joining Optus, Bayer Rosmarin spent 14 years with Commonwealth Bank of Australia (CBA) in a variety of executive roles, including Group Executive, Institutional Banking and Markets.

### Dr Franziska Brantner



Parliamentary State Secretary at the Federal Ministry for Economic Affairs and Climate Action, Federal Republic of Germany

Dr Brantner is the Parliamentary State Secretary at the Federal Ministry for Economic Affairs and Climate Action. She graduated from Sciences Po Paris and holds a Master of International Affairs from Columbia University in New York and a doctorate in social sciences from the University of Mannheim. In 2009, Dr Brantner was elected into the European Parliament, serving as the foreign policy spokesperson for the Greens/EFA. Since 2013, she is a member of the German Bundestag and was the Parliamentary Secretary and spokesperson for European policy for the Alliance 90/The Greens parliamentary group till 2021. In her capacity as the Parliamentary State Secretary she is today responsible for Digital and Innovation Policy as well as Foreign Economic and European Policies. She is also the Federal Government's representative for the implementation of the international Extractive Industries Transparency Initiative (EITI) in Germany (D-EITI).

### Baiba Braže



#### Assistant Secretary General for Public Diplomacy, NATO

Ambassador Baiba Braže was appointed Assistant Secretary General for Public Diplomacy in May 2020. The Public Diplomacy Division (PDD) works to raise the Alliance's profile with audiences world-wide and to build support for Alliance operations and policies. Ambassador Braže advises the Secretary General on issues within her remit, oversees the coordination of all Strategic Communications activities across all NATO civilian and military bodies and commands, and also directs all public diplomacy activities (except press and media, which are directed by the NATO Spokesperson on behalf of the Secretary General). ASG PDD directs the Public Diplomacy Division (PDD), which plays a key role in conveying the Alliance's strategic and political messages to opinion formers and to the public in general. Baiba Braže was born in Riga, Latvia. She holds two Masters degrees from the University of Latvia: one in Law (1990) and another in Communication Science (2002). Ambassador Braže served most recently as Latvia's Ambassador to the United Kingdom (August 2016-early May 2020), prior to which she was Director General Security Policy and International Organizations (June 2011-January 2016) and Director General of the Communications Directorate (February 2016-July 2016) at the Latvian Foreign Ministry in Riga.

### **Adam Bry**



#### Chief Executive Officer and Co-Founder, Skydio

Adam Bry is co-founder and CEO at Skydio, the leading US drone company, and the world leader in autonomous flight. He has two decades of experience with small UAS, starting as a national champion R/C airplane aerobatics pilot. As a grad student at MIT, he did award winning research that pioneered autonomous flight for drones, transferring much of what he learned as an R/C pilot into software that enables drones to fly themselves. After graduating from MIT, Adam co-founded Google[x]'s Project Wing. He has co-authored numerous technical papers and patents, and was also recognized on MIT's TR35 list for young innovators. In 2021, Adam was appointed by the U.S. Secretary of Transportation to the FAA's Advanced Aviation Advisory Committee. Skydio's customers range from athletes and creators to critical infrastructure operators to law enforcement and U.S. and allied militaries. Skydio is the first US drone company to reach unicorn status and is backed by a16z, IVP, Next47, Accel, institutions (NVIDIA, Lockheed Martin), and angel investors (Elad Gil, Naval Ravikant, Kevin Durant).

### Carissa Bryce Christensen



#### Chief Executive Officer and Founder, BryceTech

Carissa Bryce Christensen is the Chief Executive Officer and founder of BryceTech companies in the US and the UK. She previously co-founded defense company The Tauri Group, acquired by LMI in 2019, and quantum computing software company QxBranch, acquired by Rigetti Computing in 2019. She is an active tech investor and has served on several early-stage boards. Ms. Christensen is an internationally recognized expert on the satellite and space industry, known for rigorous analysis and innovative, data-driven strategy. She co-chairs the World Economic Forum Global Future Council on Space, chairs the US board of the UN-affiliated Space Generation Advisory Council, and serves on the Advisory Council of the Aerospace Corporation Center for Space Policy and Strategy. She is a founding member of the Future Space Leaders Foundation and currently serves as Chair of the Advisory Board. She has been a Senior Advisor to the annual US Space Force Schriever Wargame. Ms. Christensen previously served on the National Research Council Space Technology Industry-Government-University Roundtable, which advises NASA, and the Space Committee of the Defense Innovation Board.

### **Kęstutis Budrys**



### Senior National Security Adviser to the President of the Republic of Lithuania

Kestutis Budrys is the National Security Adviser to the President of the Republic of Lithuania, Head of the National Security Group. He is also the Secretary of the State Defence Council and Chairman of the Intelligence Coordination Group. He took up his duties at the beginning of 2022. He has 20 years of experience in national security. Before his current position, he served for six years as Deputy Director of the State Security Department, the civilian intelligence and security service. He was responsible for technological intelligence disciplines, intelligence analysis, and threat prevention. From 2009 to 2015, Mr Budrys was Advisor to the President of the Republic of Lithuania on intelligence and defence policy. Until 2009, he held leading positions in the field of intelligence analysis. K. Budrys studied at the Institute of International Relations and Political Science of Vilnius University and holds a BA in Political Science and MA in International Relations. He has also had internships at universities in the USA and Canada.

### **Danielle Cave**



### Director, Executive, Strategy and Research, Australian Strategic Policy Institute

Danielle is the Director of Executive, Strategy and Research at the Australian Strategic Policy Institute. In this role Danielle works across the organisation on short and long term priorities and strategic initiatives. These include research and project development and delivery; stakeholder management; fundraising; recruitment and ASPI's Sydney Dialogue initiative. From 2019 to 2022 She was Deputy Director of ASPI's International Cyber Policy Centre and she remains heavily involved in ICPC's work. In this previous role Danielle led on the centre's research, staff management, recruitment and program management. He took the position of Director General of NSPO (National Space Organization). Taiwan in 2021, NSPO was promoted to be the independent space agency of Taiwan and was changed to TASA (Taiwan Space Agency) officially in January 2023.
